**ORIGINAL PETITION FOR PROTECTION OF CHILDREN IN AN  
EMERGENCY AND FOR CONSERVATORSHIP IN SUIT  
AFFECTING THE PARENT-CHILD RELATIONSHIP**

This Original Petition For Protection Of Children In An Emergency And For Conservatorship In Suit Affecting The Parent-Child Relationship (the "Petition") is brought by the Department Of Family And Protective Services (the "Department"), the address of which is 622 South Oakes, Suite L, San Angelo, Texas 76903-7035, for the purposes of § 30.015, TEXAS CIVIL PRACTICE AND REMEDIES CODE. The Department has standing to bring this suit under §§ 102.003(5) and 262.001, TEXAS FAMILY CODE.

1. **Discovery Level.**

Discovery in this case is intended to be conducted under Level 3, pursuant to a discovery control plan order approved by the Court as provided by Rule 190.4, TEXAS RULES OF CIVIL PROCEDURE, unless modified by order pursuant to Rule 190.5, TEXAS RULES OF CIVIL PROCEDURE. The Department requests that the Court enter a discovery control order as required by Rule 190.4, TEXAS RULES OF CIVIL PROCEDURE, at the conclusion of the adversary hearing required by Section 262.201, TEXAS FAMILY CODE.

2. **Jurisdiction.**

2.1. This Court has jurisdiction of the suit affecting the parent-child relationship and of the suit for protection of children under Chapter 262, TEXAS FAMILY CODE, and Petitioner believes no other court has continuing, exclusive jurisdiction over the children.

2.2. In accordance with § 155.101(a), TEXAS FAMILY CODE, the Department will request that the Bureau of Vital Statistics identify the court that last had continuing, exclusive jurisdiction, or confirm that each of the children have not been the subject of a suit resulting in a court of continuing jurisdiction.

2.3. Information required by Section 152.209 of the TEXAS FAMILY CODE is provided in the affidavit attached to this Petition. This Court has emergency and/or home state jurisdiction under the Uniform Child Custody Jurisdiction and Enforcement Act.

**3. Permissive Joinder of Respondents.**

3.1. Pursuant to Rule 40 of the TEXAS RULES OF CIVIL PROCEDURE, Petitioner has elected to join a number of children and alleged parents as Respondents in this action.

3.2. Petitioner has not at the time of filing of this Petition been able to determine the identities of the children and/or the alleged parents of each child.

3.3. At such time as the Department can identify a child and his or her alleged parents, the Department will request that the cause of action involving that child and his or her alleged parents be severed from this action and maintained as a separate action. At that time, the Department will file a separate petition on that child's behalf.

**4. The Children.**

The following children are the subject of this suit:

330 unidentified children removed from the YFZ Ranch, Eldorado, Schleicher County, Texas, including but not limited to any children identified on Schedule "A" attached to this Petition and incorporated herein for all purposes as if set forth verbatim in the body of this Petition.

**5. Parties To Be Served.**

5.1. The alleged mother(s) of the children the subject of this suit have not yet been identified or located, and are unknown to the Department at this time, unless identified on Schedule "B" attached to this Petition and incorporated herein for all purposes as if set forth verbatim in the body of this Petition.

The Department requests that process be personally served on each alleged mother at the address listed with that alleged mother's name on Schedule "B" attached to this Petition, if any there be, or at such other place(s) where each such alleged mother may be located. Alternatively, citation by publication or other substituted service may be

necessary for the reasons stated in the attached affidavit or in an affidavit that will be filed with the Court.

- 5.2. The alleged father(s) of the children the subject of this suit have not yet been identified or located, and are unknown to the Department at this time, unless identified on Schedule "B" attached to this Petition and incorporated herein for all purposes as if set forth verbatim in the body of this Petition.

The Department requests that process be personally served on each alleged father at the address listed with that alleged father's name on Schedule "B" attached to this Petition, if any there be, or at such other place(s) where each such alleged father may be located. Alternatively, citation by publication or other substituted service may be necessary for the reasons stated in the attached affidavit or in an affidavit that will be filed with the Court.

- 5.3. To the best of the Department's knowledge, there are no court-ordered conservatorships, guardianships, or other court-ordered relationships affecting any of the children the subject of this suit.
- 5.4. The Attorney General's office will be served by mail under Rule 21a, TEXAS RULES OF CIVIL PROCEDURE at P.O. Box 12017, Austin, Texas 78711-2017, pursuant to § 102.009(d), TEXAS FAMILY CODE.

**6. Interstate Compact On The Placement Of Children.**

A verified statement of compliance with Subchapter B, Chapter 162, TEXAS FAMILY CODE, as required by § 162.002, TEXAS FAMILY CODE is contained in the affidavit attached to this Petition, which affidavit is incorporated herein by this reference for all purposes.

**7. Property Owned By The Children.**

To the best of the Department's knowledge no property of consequence is owned or possessed by any of the children the subject of this suit.

**8. Reasonable Efforts To Reunify Family.**

- 8.1. The Department made reasonable efforts, consistent with time and circumstances prior to the children's removal and prior to the placement of the children in foster care, to prevent or eliminate the need for removal of the children and the Department has made

reasonable efforts to make it possible for the children to return to their home(s).

- 8.2. The Department will make reasonable efforts to eliminate the need for the children's removal and to enable the return of the children to the parents.

**9. Request For Emergency Orders.**

- 9.1. On or about **April 6, 2008**, the children the subject of this suit were taken into the possession of the Department in compliance with § 262.104, TEXAS FAMILY CODE.
- 9.2. The Department has attached to this Petition an affidavit setting out the facts of this case, which affidavit is incorporated herein by this reference for all purposes.
- 9.3. There is a continuing danger to the physical health or safety of the children if returned to the parent, managing conservator, possessory conservator, guardian, caretaker, or custodian who was entitled to possession of the children or alternatively, evidence shows that the children have been the victims of sexual abuse on one or more occasions and that there is a substantial risk that the children will be the victims of sexual abuse in the future and/or there is evidence that the household to which the children would be returned to includes a person who has abused or neglected another child in a manner that caused serious injury to another child and/or sexually abused another child.
- 9.4. The nature of the emergency and the continuing danger to the welfare of the children make efforts to allow the children to remain with or return to the persons entitled to possession of the children impossible or unreasonable.
- 9.5. The continuation of the children in their homes would be contrary to the children's welfare and reasonable efforts, consistent with the circumstances and providing for the safety of the children, were made to prevent or eliminate the need for removal of the children.

**10. Temporary Managing Conservatorship.**

The Department requests that the Court immediately, without notice or an adversary hearing, appoint the Department as temporary sole managing

conservator of the children as provided in Chapter 262 and § 105.001(a)(1) and (h), TEXAS FAMILY CODE.

**11. Required Information.**

- 11.1. The Department requests that each parent, alleged father or alleged mother, or relative of each of the children before the Court provide the full name and current address or whereabouts and phone number of any absent parent of each of the children the subject of this suit pursuant to Rule 194, TEXAS RULES OF CIVIL PROCEDURE, and §262.201, TEXAS FAMILY CODE.
- 11.2. The Department requests that each parent, alleged father or alleged mother, or relative of each of the children before the Court submit the Child Placement Resources Form provided under § 261.307, if the form has not previously been provided, and provide the Department and the Court the full name and current address or whereabouts and phone number of any and all relatives of each of the children the subject of this suit with whom the Department may place each of the children during the pendency of this suit, pursuant to Rule 194, TEXAS RULES OF CIVIL PROCEDURE, and § 262.201, TEXAS FAMILY CODE.
- 11.3. The Department requests that each parent of each of the children the subject of this suit furnish information sufficient to accurately identify that parent's net resources and ability to pay child support along with copies of income tax returns for the past two years, any financial statements, bank statements, and current pay stubs, pursuant to Rule 196, TEXAS RULES OF CIVIL PROCEDURE, and § 154.063, TEXAS FAMILY CODE.
- 11.4. The Department requests that each parent of each of the children the subject of this suit provide to the Department and the Court evidence of health insurance available for the child, pursuant to Rule 196, TEXAS RULES OF CIVIL PROCEDURE, and § 154.182, TEXAS FAMILY CODE.
  - 11.4.1. Further that if private health insurance is in effect, the Department requests that each parent provide the identity of the insurance company, the policy number, which parent is responsible for the payment of any insurance premium, whether the coverage is provided through a parent's employment, and the cost of such premium.

11.4.2. If private health insurance is not in effect, the Department requests that each parent provide information on whether or not the child is receiving medical assistance under Chapter 32 Human Resource Code; or the child is receiving health benefits coverage under the state child health plan under chapter 62, Health and Safety Code and the cost of any premium or if either parent has access to private health insurance at reasonable cost to the parent.

11.5. The Department requests that each Respondent provide the Department and the Court information sufficient to establish the parentage and immigration status of each of the children, including but not limited to marriage records, birth or death certificates, baptismal records, Social Security cards, records of lawful permanent residence ("green cards"), naturalization certificates, or any other Immigration and Naturalization Service records of lawful entry.

11.6. The Department requests that each Respondent furnish to the Department all information necessary to ensure the Department has an adequate medical history for each of the children, including but not limited to immunization records and the names and addresses of all treating physicians. The Department requests the Court order each parent to provide information regarding the medical history of the parent and parent's ancestors on the medical history report form, pursuant to § 161.2021, TEXAS FAMILY CODE.

11.7. The Department requests that, at the full adversary hearing in this cause, the Court order each of the Respondents to execute an authorization for the release of the Respondent's medical and mental health records to the Department, and to further provide the Department with a list of the names and addresses of the physicians and mental health providers who have treated the Respondents.

## **12. Determination Of Parentage: MATERNITY.**

12.1. The Department requests the Court to determine whether or not any person claiming to be or identified to be the mother of any of the children the subject of this suit is, in fact, the mother of any of the children the subject of this suit, pursuant to Chapter 160, TEXAS FAMILY CODE.

12.2. If a person appears and claims to be the mother of any of the children the subject of this suit and any party denies maternity, the Court should

immediately order the alleged father, the alleged mother, and the relevant child or children the subject of this suit to submit to genetic testing pursuant to § 160.502 TEXAS FAMILY CODE.

12.3. Any person, on final hearing, adjudicated to be the mother, should be ordered to pay retroactive support pursuant to § 154.009, TEXAS FAMILY CODE.

**13. Determination Of Parentage: PATERNITY.**

13.1. The Department requests the Court to determine whether or not any person identified in this Petition as an alleged or presumed father of any of the children the subject of this suit, is in fact, the father of the child the subject of this suit, pursuant to Chapter 160, TEXAS FAMILY CODE.

13.2. If a party identified as a presumed or alleged father of any of the children the subject of this suit appears and any party denies paternity, the Department requests this Court immediately to order the mother, the alleged father, the presumed father, and the relevant child or children to submit to parentage testing pursuant to § 160.502 TEXAS FAMILY CODE.

13.3. If a party identified as a presumed or alleged father of any of the children, on final hearing, is adjudicated to be the father, the Department requests that he be ordered to pay retroactive support pursuant to § 154.009, TEXAS FAMILY CODE, from the birth of the child.

13.4. If any party denies the presumption that a man presumed to be the father of a child under Chapter 160, TEXAS FAMILY CODE, is in fact the biological father of a child subject of this suit, the Department requests that the Court order parentage testing and pretrial proceedings as provided by Chapter 160, TEXAS FAMILY CODE, if such testing is permitted by this Chapter.

**14. Request For Temporary Orders.**

At the full adversary hearing under §262.201, TEXAS FAMILY CODE, the Court should render temporary orders under §105.001, TEXAS FAMILY CODE, to include but not be limited to:

14.1. A provision appointing the Department temporary sole managing conservator of the children, with all of the rights and duties listed in

§ 153.371, TEXAS FAMILY CODE, pending the final disposition of this suit;

- 14.1.1. A provision authorizing the Department or its employee or designee to consent to medical care for the subject children, pursuant to § 266.004, TEXAS FAMILY CODE;
- 14.2. A provision pursuant to §154.001(b), TEXAS FAMILY CODE, ordering the parents of each of the children to make payments for the temporary support of their child or children, pending final disposition of this suit, these child support payments to be withheld from their disposable earnings;
- 14.3. A provision ordering the parents of each of the children to provide health insurance for their child or children under §§ 154.182 and 154.183, TEXAS FAMILY CODE, pending final disposition of the suit;
- 14.4. A provision restricting the parents' possession and access to their child or children the subject of this suit;
- 14.5. A provision for the preparation of a social study into the circumstances and conditions of each of the children and the home of any person requesting managing conservatorship or possession of each of the children;
- 14.6. A provision ordering the parents of each of the children to submit to the Department the Child Placement Resources Form required under § 261.307, TEXAS FAMILY CODE;
- 14.7. A provision ordering the parents of each of the children to submit to psychological and/or psychiatric examinations;
- 14.8. A provision ordering the parents of each of the children to attend counseling sessions to address the specific issues that led to the removal of the children from the home and to attend counseling sessions to address any additional issues arising from the psychological and/or psychiatric examination(s), or from the counseling sessions;
- 14.9. A provision ordering the parents of each of the children to attend parenting classes as requested by the Department;

- 14.10. A provision ordering the Respondents to submit to a drug and alcohol assessment and to complete a substance abuse treatment program if needed;
- 14.11. A provision ordering the parents of each of the children to comply with each requirement set out in the Department's original, or any amended, service plan during the pendency of this suit, as provided by §§ 263.106 and 153.602, TEXAS FAMILY CODE;
- 14.12. A provision ordering the Respondents to provide the Court and the Department with a current residence address and telephone number at which each can be located and contacted;
- 14.13. A provision ordering the Respondents to notify the Court and the Department of any change in his or her residence address or telephone number within five (5) days of a change of address or telephone number.

**15. Permanent Conservatorship And Support Of The Children.**

**15.1. Conservatorship.**

- 15.1.1. Pursuant to §§ 153.005 and 263.404, TEXAS FAMILY CODE, if any of the children cannot safely be reunified with a parent, but may be permanently placed with a relative or other suitable person, the Department requests that the Court appoint the person as permanent sole managing conservator of the children; if the children cannot safely be reunified with either parent or permanently placed with a relative or other suitable person, the Department requests that the Court appoint the Department as permanent sole managing conservator of the children.
- 15.1.2. Pursuant to § 153.131, TEXAS FAMILY CODE, the Petitioner alleges that appointment of the parent or parents would not be in the child's best interest, because the appointment would significantly impair the child's physical health or emotional development.
- 15.1.3. If conservatorship is awarded under this paragraph, the application of the guidelines for possession and access to the children, as set out in §§ 153.311, *et seq.*, TEXAS FAMILY CODE, would not be in the children's best interest. The parents of the

children, as possessory conservators of the children, should have limited access to and possession of the children, under conditions and restrictions prescribed by the Court for the best interests of the children.

**15.2. Support.**

15.2.1. Each parent should be ordered to make payments for the support of the children in accordance with § 154.001(b), TEXAS FAMILY CODE, including retroactive support if appropriate, determined pursuant to §.154.131, TEXAS FAMILY CODE, and in a manner specified by the Court under Chapter 154, TEXAS FAMILY CODE. The payments for the support of the children should survive the death of either parent and become the obligation of the deceased parent's estate.

15.2.2. Each parent should be ordered to provide health insurance for the children in accordance with §§ 154.182 and 154.183, TEXAS FAMILY CODE.

15.2.3. If either parent is found to be in arrears in child support or medical support payments ordered in this or in any other action, a judgment for enforcement of said arrearage should be issued against that parent pursuant to §§ 157.261, 158.003 and 158.004, TEXAS FAMILY CODE.

**16. Attorney Ad Litem And Guardian Ad Litem For The Children.**

16.1. The immediate appointment of an attorney *ad litem* for the children is required by § 107.012, TEXAS FAMILY CODE.

16.2. The immediate appointment of a guardian *ad litem* to represent the interests of the children is required by § 107.011, TEXAS FAMILY CODE.

16.3. Petitioner would show the Court that the Department possesses information which may be essential to the work of the attorney *ad litem* and guardian *ad litem*, but which cannot be provided, except by direction of this Court, without the editing required by § 261.201(g), TEXAS FAMILY CODE. Resource limitations will result in substantial delay in providing the information if the editing must be done before release. The release of all files, reports, records, communications and working papers used or developed in the investigation or in the providing of services to the children the subject of this suit to the attorney *ad litem*

and guardian *ad litem* is in the best interests of the children, is essential to the administration of justice, and is not likely to endanger the life or safety of any person. If the Court determines that release of the information to the attorney *ad litem* and guardian *ad litem*, as officers of the Court, without editing should be made, the Department requests that appropriate orders be made to prevent further disclosure of the information.

**17. Attorneys For Parents And Respondents;  
Payment Of Attorney Ad Litem Fees And Expenses.**

**17.1. Indigent Parent.**

If a parent responds in opposition to this suit affecting the parent-child relationship and appears without attorney, the Department requests that the Court determine whether or not the parent is indigent. If the Court determines that the parent is indigent, the appointment of an attorney *ad litem* to represent the interests of that parent is required by § 107.013, TEXAS FAMILY CODE. The Court may appoint one attorney to represent both indigent parents if the parents' interests are not in conflict.

**17.2. Other Parents Entitled To Appointment Of Attorney Ad Litem.**

If a parent is served with citation by publication or service is not required pursuant to § 161.002(c) or (d), TEXAS FAMILY CODE, the appointment of an attorney *ad litem* for the absent parent is required by § 107.013, TEXAS FAMILY CODE.

**17.3. Payment Of Fees For Attorneys Ad Litem.**

The Department requests that attorney's fees for any attorney *ad litem* be assessed and paid in accordance with § 107.015, TEXAS FAMILY CODE.

**18. Statutory Warning To Parents.**

The Department requests that the Court inform each parent in open court as required by §§ 262.201(c), 262.205(c)(2) and 263.006, TEXAS FAMILY CODE, at the adversary hearing, at the status hearing, and at each subsequent permanency hearing that parental and custodial rights and duties may be subject to restriction or to termination unless the parent or parents are willing and able to provide the children with a safe environment.

19. **Prayer.**

- 19.1. The Department prays that citation and notice issue as required by law, and that the Court enter temporary and final orders in accordance with the allegations of this Petition.
- 19.2. The Department prays that the Court immediately grant emergency orders in conformity with the allegations of this Petition.
- 19.3. The Department prays for attorney's fees, expenses, and costs.
- 19.4. The Department prays for general relief.

**BEFORE ME**, the undersigned authority, personally appeared **Lynn McFadden**, who was sworn by me and deposed as follows:

“My name is **Lynn McFadden**. I am of sound mind, over the age of 18, and capable of making this Affidavit. I am an Investigative Supervisor for the Department of Family and Protective Services (the “Department”), and I am authorized on the behalf of the Department to make this Affidavit. I have reviewed the Department’s Original Petition For Protection Of A Child In An Emergency And For Conservatorship In Suit Affecting The Parent-Child Relationship (the “Petition”), and the facts stated in the Petition and in this Affidavit are within my personal knowledge and are true and correct.”

**1. Information To Be Submitted To The Court Pursuant To The Uniform Child Custody Jurisdiction And Enforcement Act.**

“The present address of the child the subject of this suit is:

YFZ Ranch,  
Eldorado, Schleicher County, Texas

"To the best of my knowledge, the Department:

"has not participated in any capacity in any other litigation concerning the custody of the child in this or any other state;"

"does not have information of any proceeding concerning the child pending in a court of this or any other state;"

"does not know of any person not a party to the proceedings who has physical custody of the child or who claims to have custody or visitation rights with respect to the child."

**2. Interstate Compact On The Placement Of Children.**

"At the time of the filing of this Petition, an interstate placement is not planned, but the Department of Family and Protective Services will comply with all requirements of the Interstate Compact on the Placement of Children as set forth in Chapter 162, Subchapter B, TEX. FAM. CODE.

**3. Facts Necessitating Removal Of The Child.**

On March 29, 2008, the Department received an intake report at 11:32 p.m. According to the intake, a teenaged mother (age 16) and her infant child (age approximately 8 months) were requesting assistance to enable them to leave the YFZ Ranch located near Eldorado, Schleicher County, Texas, which ranch is owned by the Fundamental Church of Jesus Christ of Latter Day Saints and which consists of a large compound containing numerous multi-story residential household complexes and other buildings inhabited by a large number of members of that church.

The teenaged mother had called a local family violence shelter several times that day expressing the need to leave her current living situation. She reported that she was brought to the YFZ Ranch by her parents about three years ago. She stated that about two years after her arrival on the YFZ Ranch (or about one year prior to the date of this report and when she would have been 15 years old), she was spiritually married to an adult male member of the church (approximate age 49 years old) at the YFZ Ranch. She indicated that the adult male was also married to several other women and that she was wife number seven.

The teenaged mother stated that she began to be abused shortly after she started living at the YFZ Ranch. She advised that the adult male would "beat and hurt" her whenever he got angry. According to the caller, this would include the man hitting her in the chest and choking her and that while such abuse was occurring one of the other women in the home would hold her infant child. She reported that the last time he beat her was on Easter Sunday 2008. The report also indicated that, on a previous occasion, the man had beaten her so severely that it resulted in her having several broken ribs, for which she was taken to the hospital. She reported that the doctor wrapped her torso in an ace bandage and told her to "take it easy for a few days". She also indicated that the man would hurt her, explaining that he would force himself on her sexually. She also indicated that she is several weeks pregnant.

The teenager mother stated that she was not allowed to leave the YFZ Ranch, unless it was to receive medical care, in which case the man would drive her and one of the other women from the YFZ Ranch would go into the hospital with her. She indicated that she had tried to devise a plan to escape from the YFZ Ranch by pretending to be ill and needing to receive medical care, but determined this would not work since she would not be allowed to take her infant child with her unless the child was also sick.

She indicated during the conversations that she was calling using someone else's cell phone and she was reported to be very, very quiet throughout the conversations for fear that she would be overheard and would get in trouble. She stated that her parents do not live on the YFZ Ranch and that she has not had any contact with them to explain that she does not want to continue to be on the ranch.

Subsequently, on March 30, 2008, the teenaged mother again contacted staff at a local family shelter. During this conversation, she again stated that she

and an adult male resident of the ranch had been married in a spiritual union through the church, but there was no formal marriage, and that the man had three other "wives" living on the YFZ Ranch. She reported that the man had previously gone away for a while to the "outsider's world", but she said she did not know why he left the ranch.

The Department, as part of its investigation, subsequently determined that the man identified by the teenager had been indicted in Mohave County, Arizona, on criminal charges of sexual conduct with a minor and conspiracy to commit sexual conduct with a minor in connection with a purported marriage to a minor in Arizona, with whom he had conceived a child. Information obtained by the Department indicated that the man pled no contest in August of 2007 to conspiracy to commit sexual conduct with a minor, and he was convicted of that offense. Information obtained by the Department also indicated that, as part of the plea agreement, the sexual conduct with a minor charge was dismissed. The man was sentenced to 45 days in jail and required to serve three years probation. As part of his sentence, he is required to register as a sex offender until he successfully completes his probation.

During the March 30, 2008 conversation, the teenager indicated that she was being held against her will at the YFZ Ranch and church members had told her that if she tried to leave, she will be found and locked up. She also expressed during this conversation concerns about what would happen to her if she were to leave the YFZ Ranch. She reported that church members have told her if she leaves the ranch, outsiders will hurt her, force her to cut her hair, to wear make up and clothes and to have sex with lots of men. She also indicated that her parents, who had returned to their hometown outside the State, were preparing to send her 15 year old sister to live at the YFZ Ranch. At the conclusion of this conversation, she began crying and then stated that she is happy and fine and does not want to get into trouble and that everything she had previously said should be forgotten.

Based on the above information, the Department obtained orders for investigation of child abuse from the 51<sup>st</sup> Judicial District Judge authorizing the Department to gain access to the YFZ Ranch for purposes of conducting an investigation of these allegations, including transporting and interviewing children located at the YFZ Ranch for purposes of the investigation. In cooperation with a criminal investigation being conducted by law enforcement, the Department began investigating these allegations. Further investigation conducted by the Department has unearthed additional information concerning other minor residents of the YFZ Ranch.

While searching for the teenaged mother and her infant child, investigators at the YFZ Ranch observed a number of young teenaged girls who appeared to be minors and appeared to be pregnant, as well as several teenaged girls who already had given birth and had their own infants. Investigators determined that there is a wide-spread pattern and practice among the residents of the YFZ Ranch in which young minor female residents are conditioned to expect and accept sexual activity with adult men at the ranch upon being spiritually married to them. Under this practice, once a minor female child is determine by the leaders of the YFZ Ranch to have reached child bearing age (approximately 13-14 years old) they are then "spiritually married" to an adult male member of the church and they are required to then to engage in sexually activity with such male for the purpose of having children. It is the pattern and practice of the adult males to have more than one spiritual wife resulting in them having sexual relationships with a number of women, some of who are minors. Minor boy children are expected, after they reach adult age and when their spiritual leader determines appropriate, to enter into a spiritual marriage with a female member of the church designated by the leader, which female may be a minor.

Based on the Department's joint investigation with law enforcement of the circumstances existing on the YFZ Ranch, the Department determined that an immediate danger exists to the physical health or safety of the children who are residents of the YFZ Ranch and/or that the children who are residents of the YFZ Ranch are the victims of neglect and/or sexual abuse and that their continuing to reside on the YFZ Ranch would be contrary to the children's welfare. As set forth in this Affidavit, there is a pervasive pattern and practice of indoctrinating and grooming minor female children to accept spiritual marriages to adult male members of the YFZ Ranch resulting in them being sexually abused. Similarly, minor boys residing on the YFZ Ranch, after they become adults, are spiritually married to minor female children and engage in sexual relationships with them resulting in them becoming sexually perpetrators. This pattern and practice places all of the children located at the YFZ Ranch, both male and female, to risks of emotional, physical and/or sexual abuse.

During the investigation, a number of the children interviewed were unable or unwilling to provide the names of their biological parents or identified multiple mothers and were unable or unwilling to provide information such as their own birthdates or birthplaces. The adults on the YFZ Ranch also, in many instances, provided limited information to no information about parentage of the children or other information identifying the proper name, age or date of birth of children located on the YFZ Ranch. This has made it difficult to determine who are the parents of the children located on the YFZ Ranch.



4. **Facts Supporting Citation By Publication Or Other Substituted Service Of An Absent Party.**



Therefore, the Department believes it is necessary to request citation by publication by posting on an unknown mother and/or unknown father of the child as alleged in the Petition.

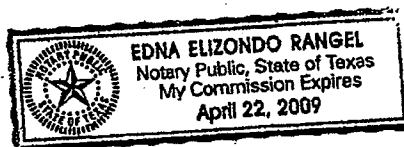
"Based on the above facts, I believe there is an immediate danger to the physical health or safety of the child, and there is no time, consistent with the physical and emotional health or safety of the child, for an adversary hearing. I further believe that there is a continuing danger to the physical health or safety of the child if the child is returned to the care of the parents or other person entitled to possession of the child due to concerns that the parents or other persons will return them to the YFZ Ranch or similar environment, that the evidence shows that the child or other children located on the YFZ Ranch have been the victim of sexual abuse and there is a substantial risk that children located in the YFZ Ranch will be the victim of sexual abuse in the future; and that continuation of the child in the household would be contrary to the child's welfare."

"All reasonable efforts, consistent with the time and circumstances and providing for the safety of the child, have been made by the Department to prevent or eliminate the need for removal of the child, but it is not in the child's best interest to return the child to the parents' home at this time."

**ORDER FOR PROTECTION OF A CHILD IN AN EMERGENCY  
AND NOTICE OF HEARING**

On the date set forth below, the Department Of Family And Protective Services (the "Department") presented its Petition to the Court along with the sworn affidavit of a Department investigator.

**1. Jurisdiction.**

Having examined the pleadings and reviewed the evidence, the Court finds that it has jurisdiction of this cause under § 262.002, TEXAS FAMILY CODE.

**2. Findings.**

2.1. Having examined and reviewed the evidence, including the sworn affidavit accompanying the Petition and based upon the facts contained therein, the Court finds that all reasonable efforts, consistent with time and circumstances have been made by the Petitioner to prevent or eliminate the need for removal of the children the subject of this suit from the home and to make it possible for the children to return home, but continuation in the home would be contrary to the children's welfare.

2.2. The Court finds that the children have been removed pursuant to § 262.104, TEXAS FAMILY CODE, and further finds that:

2.2.1. There is a continuing danger to the physical health or safety of the children if the children are returned to the parent(s), managing conservator(s), possessory conservator(s), guardian(s), caretaker(s), and/or custodian(s) who are presently entitled to possession of the children; that the evidence shows that the children have been the victims of sexual abuse on one or more occasions and there is a substantial risk that the children will be the victims of sexual abuse in the future and/or there is evidence that the household(s) to which the children would be returned to includes a person who has abused or neglected

another child in a manner that caused serious injury to another child and/or sexually abused another child.

2.2.2. Continuation of the children in the home would be contrary to the children's welfare; and

2.2.3. Reasonable efforts consistent with the circumstances and providing for the safety of the children were made to prevent or eliminate the need for removal of the children.

2.3. The Court finds that the following temporary orders are in the best interest of the children the subject of this suit.

**3. Emergency Temporary Orders.**

**IT IS ORDERED** that the Department is named temporary sole managing conservator of the following child, with all of the rights and duties listed in § 153.371, TEXAS FAMILY CODE, until a full adversary hearing is held:

330 unidentified children removed from the YFZ Ranch, Eldorado, Schleicher County, Texas, including but not limited to any children identified on Schedule "A" attached to this Order and incorporated herein for all purposes as if set forth verbatim in the body of this Order.

3.1. **IT IS ORDERED** that, in addition to the rights and duties listed in § 153.371, TEXAS FAMILY CODE, the Department is authorized to consent to medical care for the children, pursuant to § 266.004, TEXAS FAMILY CODE, until a full adversary hearing is held.

3.2. **IT IS ORDERED** that each parent, alleged father or alleged mother, or relative of the children before the Court provide the Department and the Court the full name and current address or whereabouts and phone number of any absent parent or alleged father or alleged mother of the children the subject of this suit, pursuant to RULE 194, TEXAS RULE OF CIVIL PROCEDURE and §262.201, TEXAS FAMILY CODE.

3.3. **IT IS ORDERED** that each parent, alleged father or alleged mother, or relative of the children before the Court submit the Child Placement Resources Form provided under § 261.307, if the form has not previously been provided, and provide to the Department and the Court the full name and current address or whereabouts and phone number of any relative of the children the subject of this suit with whom the Department may place the children during the pendency of this suit, pursuant to Rule 197, TEXAS RULES OF CIVIL PROCEDURE, and § 262.201, TEXAS FAMILY CODE.

- 3.4. **IT IS ORDERED** that each parent of the children the subject of this suit furnish to the Department and the Court information sufficient to accurately identify that parent's net resources and ability to pay child support along with copies of income tax returns for the past two years, any financial statements, bank statements, and current pay stubs, pursuant to RULE 196, TEXAS RULES OF CIVIL PROCEDURE and § 154.063, TEXAS FAMILY CODE.
- 3.5. **IT IS ORDERED** that each parent of the children the subject of this suit provide the Department and the Court evidence of health insurance available for the children, pursuant to RULE 196, TEXAS RULES OF CIVIL PROCEDURE and § 154.182, TEXAS FAMILY CODE.
- 3.6. **IT IS ORDERED** that each Respondent provide the Department and the Court information sufficient to establish the parentage and immigration status of the children, including but not limited to marriage records, birth or death certificates, baptismal records, social security cards, records of lawful permanent residence ("green cards"), naturalization certificates, and any other Immigration and Naturalization Service records of lawful entry.
- 3.7. **IT IS ORDERED** that each Respondent furnish to the Department all information necessary to ensure the Department has an adequate medical history for the children, including but not limited to the immunization records for the children and the names and addresses of all physicians who have treated the children.
- 3.8. **IT IS ORDERED** that each Respondent provide the Department information regarding the medical history of the parent and parent's ancestors on the medical history report form, pursuant to § 161.2021, TEXAS FAMILY CODE.
- 3.9. **IT IS ORDERED** that all of the information required above be provided as ordered no later than the date of the full adversary hearing to be held in this cause.

**4. Full Adversary Hearing.**

A full adversary hearing under § 262.201, TEXAS FAMILY CODE will be held at the time and place set out below. At this hearing, the Court will consider issuing the following temporary orders:

- 4.1. A provision appointing the Department temporary sole managing conservator of the children, with all of the rights and duties listed in § 153.371, TEXAS FAMILY CODE, pending the final disposition of this suit;
- 4.2. An authorization of the Department to consent to medical care for the subject children, pursuant to § 266.004, TEXAS FAMILY CODE;
- 4.3. A provision pursuant to § 154.001(b), TEXAS FAMILY CODE, ordering each of the parents of the children to make payments for the temporary support of the children, pending final disposition of this suit, these child-support payments to be withheld from their disposable earnings;
- 4.4. A provision restricting each parent's possession of and access to the children the subject of this suit;
- 4.5. A provision ordering each of the parents of the children to submit to psychological and/or psychiatric examinations;
- 4.6. A provision ordering each parent of the children to attend counseling sessions to address the specific issues that led to the removal of the children from the home and any additional issues arising from the psychiatric and/or psychological examinations or from the counseling sessions;
- 4.7. A provision ordering each parent of the children to attend parenting classes as requested by the Department;
- 4.8. A provision ordering each Respondent to submit to a drug and alcohol assessment and to complete a substance abuse treatment program if needed;
- 4.9. A provision ordering each parent of the children to comply with each requirement set out in the Department's original, or any amended, service plan during the pendency of this suit, as provided by § 263.106, TEXAS FAMILY CODE;
- 4.10. A provision ordering each Respondent to provide the Court and the Department with a current residence address and telephone number, at which each can be located and contacted;
- 4.11. A provision ordering each Respondent to notify the Court and the Department of any change in his or her residence address or telephone number within five (5) days of a change of address or telephone number;

4.12. A provision pursuant to Rule 166b(2)(h), TEXAS RULES OF CIVIL PROCEDURE, ordering each of the Respondents, to execute an authorization for the release of that Respondent's medical and mental health records to the Department, and to further provide the Department with a list of the names and addresses of the physicians and mental health providers who have treated that Respondent.

5. **Notice Of Full Adversary Hearing.**

Notice is given to Respondents that this cause is set for a full adversary hearing on **April 17, 2008, at 10:00 o'clock a.m. in the 51<sup>st</sup> Judicial District Court of Schleicher County, Texas, sitting in San Angelo, Texas, at the Tom Green County, Texas, Courthouse.**
