Dear Max,

I read your letter of May 24, 2012 and was highly intrigued by it. I remember well when you were involved with the Veterans organizations you used to sarcastically hammer and savage me regularly and I remember it <u>very well</u>. So I can't really see you giving me too much counsel and advice about civility and harshness, and all the rest of that.

But you need to hear the full the story Max – you seldom do any more than just get a deep gut reaction and lash out about things – just as you always have. You're a fighter, a scrapper, tough, ornery, impatient, and highly emotional. I know those traits! So enclosed (and attached via email) are copies of the "flyer" that went out, and a full copy of my reply.

I also attach a copy of a missive from Colin Sword, a chap who heard of my remarks. Nearly everything in there is untrue. For one thing, I was not in DC under President Johnson. I had nothing to do with that. If anybody can't yet understand what is honestly happening with the Trust Fund – and that nobody "stole" any of it – then here are some articles on that to help clarify. How can any caring person sit aside when the Trustees – in a unanimous report – all Democrats and Republicans – are telling the people of America that in the year 2033 – instead of 2036 (they moved it all up three years in one year!) – that they will waddle up to the pay window and get a check for 25% less? What's honest or fair about that Max?

I spent my entire public life trying to put Social Security back together and make it solvent for over 75 years. Why don't you help? Why don't your pals at CARA help? If anybody still can't understand what we are trying to do for Social Security, then read the Moment of Truth report, and it's all in there (http://momentoftruthproject.org/report). We take care of the poor people in society, giving the lower 20% a 125% of poverty – and we give the "older old" an extra 1% kick a year up to 85 years of age. Come on Max – let's get honest and real with each other. You know damn well that the system was never created as a "retirement" – it was an "income supplement" to take care of folks working in CCC camps and who lost everything in the Great Depression. Rand knows those things. Rother knows those things. And you guys just keep ducking and moving like punch drunk fighters.

Some in that group of CARA were nice enough to say that Bowles and I were going to try to "privatize" Social Security. We've never said one damn word about that. That's called lying – maybe they or you would call it a "terminological inexactitude." I call it a lie.

If you have guys in your outfit who are still talking about "stealing the Social Security Trust Fund," and "balancing the budget on the backs of poor old Seniors," – and who will therefore let this extraordinary system go down the tubes, then you have no respect from me. Where were you when they took the precious payroll tax – "the life stream of Social Security" – from 6.2% down to 4.2%? I didn't hear a peep out of you. I didn't hear a peep out of your organization either – except when I got a whole ration of mail from some of your people – they said they were "urged" – obviously stimulated by you (thinking I was still in the Senate) and several of your fine and stalwart membership then referred to me as a "Nazi pig fucker." How's that for a deal? Should be an eye opener that ought to open an honest dialogue, Max. I'm ready. Call me.
