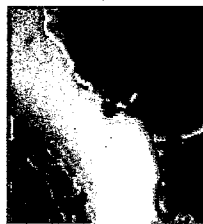


FORFEITURE ALLEGATION
