INDICTMENT

The Grand Jury for the District of Maryland charges that:

On or about May 5, 2007, in the District of Maryland, and elsewhere, the defendant,

JOHN DOE # 17,







a white male, approximately 210-250 pounds, with curly brown hair, who appears in the attached images, incorporated by reference herein as defendant, did knowingly transport and ship in interstate and foreign commerce, specifically by means of a computer, child pornography as defined in Title

18 U.S.C. § 2256(8), to-wit: a video file entitled "DV Out Tear - 02[177432] <u>"and a video file</u> entitled "DV Out Tear - Pv 02[177265]" which contain visual depictions of a pre-pubescent female posed nude and exposing her genitalia.

FORFEITURE ALLEGATION

As a result of the offense set forth in Count One, the defendant,
