35. NARRATIVE On 1/31/12 at about 1610 hrs CI (Ginger Carter) called 911 to report that V1 (Ashton) was asleep on her bed and not breathing. C2 (Robert Carter) who is the father of Ashton was also home and started CPR on Ashton. Mayville EMS arrived on scene and transported Ashton to WMH where she was pronounced dead at 1659 hrs. Upon speaking with Ginger and Robert, they stated that Ashton has had a long history of mental illness and was on medication for her depression. Ginger stated that she was with Ashton all day today. Ginger stated that she woke up around 5:00am to get her children on the bus for school. Ginger stated that Ashton woke up around 10:00am. Ginger stated that she and Ashton had coffee on the front porch. Ginger stated that Ashton seemed ok in the morning but at times seemed depressed just by the way she was talking. Ashton asked Ginger if she would watch Ashton's 10 month old baby for the day because Ashton was not feeling great. Ginger agreed. Ginger stated that she has known Ashton for a while now and is has a good friendship with Ashton and was able to handle Ashton and her depression. Soon thereafter Ginger made breakfast for Ashton and Ashton did not eat much of the breakfast that Ginger made. Ginger stated that after breakfast, Ashton went to the bathroom. Ashton was in the bathroom for a while and Ginger went to check on her. Ginger was talking to Ashton through the door and Ginger thought that something was wrong. Ginger went into the bathroom and found that Ashton had fallen into the shower. Ginger helped Ashton up from the shower and led her to Ginger's bedroom where she laid Ashton on the bed. Ginger does not know how long Ashton was in the bed but went into the bedroom with the baby and put it on the bed with Ashton in the hopes that Ashton would wake up and play with the baby. Ginger stated that Ashton did not wake up but seemed to be ok and just sleeping. Ginger stated that she looked at Ashton and she had all the color to her skin and was breathing. Ginger took the baby out of the room and closed the door. A little while later Ginger brought the baby back into the room and was feeding the baby on the bed. Ginger stated that Ashton still did not wake up but seemed fine. Ginger then took the baby out of the room and closed the door. Robert came home soon thereafter and around 4:16 pm, Ashton was found in the bedroom not breathing or responding. Robert tried to perform CPR on Ashton. Then Ashton was transported to WMH. Coroner Mackowiak responded to WMH where he stated that a full autopsy will be conducted. Investigation is continuing.

35	<p>On 1/31/12 writer was interviewing Ginger at WPD with Ptlm. Cummings in regards to Leslie Ashton's overdose. Ginger appeared to be under the influence of an unknown drug at the time of the interview. Ginger had slurred speech, pin point pupils, glassy eyes and kept falling asleep. Writer and Ptlm. Cummings asked Ginger if she had taken anything that may make her appear to be intoxicated or under the influence. Ginger stated that she took 5-6 pills for her depression (Possibly Xanax). Ginger was progressively getting worse as the interview went on and writer and Ptlm. Cummings felt that Ginger may be overdosing on her medication. Ginger stated that she is only supposed to take 4, but Robert gave her an extra one because of Leslie passing away. Writer will submit the unfinished statement that Ginger started to make before she was transported to WMH. Writer will forward all information and paperwork to SD 111. Investigation is continuing.</p>
